

RESOLUTION NO. 2

A RESOLUTION ADOPTING THE CERTIFICATE OF THE RESULTS OF THE SPECIAL BOND ELECTION HELD IN THE TOWN OF AVONDALE, ARIZONA, ON THE 8TH DAY OF JUNE, 1948, AND AUTHORIZING THE RECORDING AND FILING THEREOF IN THE OFFICE OF THE COUNTY RECORDER OF MARICOPA COUNTY, ARIZONA.

WHEREAS, the Mayor and Common Council of the Town of Avondale, Arizona, have duly canvassed the returns of the special election held in and for the Town of Avondale, on the 8th day of June, 1948, said canvassing having been made on the 21st day of June, 1948.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF AVONDALE, ARIZONA:

Section 1, That the following certificate of results of special election is hereby adopted and approved by the Mayor and Common Council of the Town of Avondale, Arizona:

CERTIFICATE OF RESULTS OF SPECIAL ELECTION, HELD IN THE TOWN OF AVONDALE, ARIZONA, ON 8TH DAY OF JUNE, 1948.

IT IS HEREBY CERTIFIED by the undersigned, the Mayor and Members of the Common Council of the Town of Avondale, Arizona, as follows:

1. That a special election was duly called and held in the Town of Avondale, Arizona, on the 8th day of June, 1948, at which election there was submitted to the real property taxpayers who were also in all respects qualified electors of the Town of Avondale, the question of issuing revenue bonds in the principal aggregate amount of One Hundred Thousand (\$100,000.00) Dollars, to be in denominations of One Thousand (\$1,000.00) Dollars, each numbered from one (1) to one hundred (100), both inclusive.

The proceeds of the sale of said bonds shall be used for the purpose of purchasing, acquiring and making improvements and additions to the WHYMAN WATER WORKS, a privately owned public water utility, doing business and operated in said town, consisting

1 generally of a complete water works system, as well as distribution  
2 lines thereof, and pertaining to the distributing business of said  
3 utility, whether situated within or without said town.

4 2. That the poll and tally lists, and the certified re-  
5 turns of the election board which conducted said special election  
6 were filed in the office of the Town Clerk of the Town of Avondale,  
7 on the 8th day of June, 1948, being a day within twelve (12) days  
8 after the date upon which said special election was held, and that  
9 on the first Monday succeeding the twelfth day after said election,  
10 being the 21st day of June, 1948, the Mayor and Common Council of  
11 the Town of Avondale met at their regular place of meeting, in the  
12 Town Hall of the Town of Avondale, Arizona, and canvassed the re-  
13 turns of said special election.

14 3. That we, the undersigned Mayor and Common Council  
15 of the Town of Avondale, Arizona, do further certify that the ob-  
16 ject of said special election was to obtain authority from the real  
17 property taxpayers, who are also in all respects qualified electors  
18 in said Town, to issue and sell water works revenue bonds of said  
19 Town in the aggregate principal amount of One Hundred Thousand  
20 (\$100,000.00) Dollars, for the purpose of purchasing, acquiring and  
21 making improvements and additions to the WHYMAN WATER WORKS, a pri-  
22 vately owned public water utility, doing business and operated in  
23 said town.

24 4. That we do further find and certify, after careful and  
25 complete canvass of said election returns, that a total of 137  
26 ballots was cast at said election; that of said number of ballots  
27 124 thereof were marked, "Bonds, Yes", and that 4 thereof were  
28 marked, "Bonds, No," and that 9 of such ballots were spoiled and  
29 rejected, and that a majority of the real property taxpayers, who  
30 were also in all respects qualified electors of said Town of Avon-  
31 dale, voting at said election, voted to authorize the issuance and  
32 sale of the aforesaid water works revenue bonds.


