I agree to indemnify and hold harmless and defend the City and its officers, agents, volunteers, and employees for, from and against any and all losses, claims, damages, and liabilities of any nature, including all costs, expenses, and attorney's fees, arising out of, connected with, or in any way associated with use of the City of Avondale Park and participation in activities related to the event listed above.
4. This release shall be legally binding upon me, my heirs, estate, administrators, guardians, personal representatives and assigns. Any action which may arise by virtue of this release or from my use of the city of Avondale Parks shall be governed in accordance with the laws of the State of Arizona.
